

AUCTIONEER LICENCE **COURSE** January - June 2017



The REIQ runs all the competencies required by Fair Trading to make an application to gain a Auctioneer Licence (real property) or Chattel Auctioneer Licence.

The individual competencies can be undertaken by contact class at any of our training centres throughout the state, (CPPDSM4004A Conduct auction is trained at our Brisbane training centre only) or complete your course online. Students studying in class will be issued with hard copy manuals when they attend each competency. Both contact class and online students complete their assessments* online. If you prefer printed assessments an additional \$50 fee applies. Online students have the option of receiving their manuals in hard copy for an additional \$50.

If you have current experience or knowledge in this area, you may like to apply for Recognition of Prior Learning (RPL). Contact us if you would like further information | 3249 7347.

*CPPDSM4004A Conduct auction assessment consists of a theoretical component and a practical component. This unit can be undertaken by a combination of contact class and online for either component or by RPL for the entire unit. If you elect to complete the assessment online, the practical component must be in the form of a DVD or video showing the student conducting a mock auction.

Once you have completed the required units of competency with the REIQ you will be issued with a Statement of Attainment and Transcript. You then need to complete and submit your application (New licence application Form 1-1 Notes) to the Office of Fair Trading www.fairtrading.qld.gov.au

If you wish to work as an auctioneer in the real estate profession you are required to hold a current auctioneer licence. The auctioneer licence will allow you to sell by auction real property:

- dwellings,
- community title lots,
- businesses or
- vacant land.

There are 5 required competencies for an auctioneer (real property) under the Property Occupations Act 2014.

you must have a current chattel auctioneer licence.
