

SCHOLARSHIP TERMS AND CONDITIONS

The Property Manager Job Ready Scholarship sponsored by Smoke Alarm Solutions

1. INTRODUCTION

These Scholarship Terms and Conditions apply to The Property Manager Job Ready Scholarship (the **Scholarship**) sponsored by Smoke Alarm Solutions, being a paid scholarship for the PM Job Ready Program delivered by the Real Estate Institute of Queensland (**REIQ**).

The REIQ reserves the right to make minor amendments to these terms and conditions without prior notice.

2. DEFINITIONS

- (a) **Applicant** means any person that applies for the Scholarship.
- (b) **Program** means the nominated delivery of the PM Job Ready Program provided by the REIQ as indicated in the related advertising material of the Scholarship.
- (c) **REIQ RTO Policies** means:

 - iv. [RTO Complaints Policy](#).
- (d) **Scholarship Recipient** means the successful Applicant that receives and accepts the offer of the Scholarship.

3. APPLYING FOR THE SCHOLARSHIP

- (a) Applicants must submit the Scholarship application to the REIQ, in the required format and by the closing date and time as specified by the REIQ. By submitting an application for the Scholarship, the Applicant agrees to be bound by these terms and conditions.
- (b) To be considered, applications must:
 - i. be completed in full;
 - ii. include the Applicant's full name and contact details; and
 - iii. include all relevant information in support as required by the REIQ and Smoke Alarm Solutions set out on the [Competition Entry Page](#).
- (c) The Scholarship Recipient shall be selected by Smoke Alarm Solutions and REIQ in their sole and absolute discretion. The Scholarship Recipient shall be notified if they are successful within fourteen (14) days of the closing date.

4. BENEFITS

The Scholarship Recipient will be exempt from course fees for the nominated Program. The Scholarship is not redeemable for the equivalent monetary value. Scholarship Recipients who enrol for any other REIQ training course beyond the nominated Program shall be liable for paying any relevant course fees.

5. CONDITIONS

5.1 Enrolment

The Scholarship is conditional on the Scholarship Recipient's enrolment in the nominated Program for the duration of the Program.

5.2 Nominated Program

The Scholarship shall apply to a nominated delivery of the Program at the location and on the dates as specified in the advertisement of the Scholarship. If the Scholarship Recipient wishes to transfer the benefit to a different delivery of the Program, they must seek the written approval of the REIQ. The REIQ may in its sole discretion reject the Scholarship Recipient's request subject to enrolment numbers and availability.

5.3 REIQ RTO Policies

- (a) The Scholarship is conditional on the Scholarship Recipient agreeing to and/or accepting the REIQ RTO Policies.
- (b) By accepting the offer of the Scholarship, the Scholarship Recipient accepts and agrees to be bound by the REIQ RTO Policies.
